Coronel		<p>SHEILA CORONEL, Director, Stabile Center for Investigative journalism; Professor of Professional Practice, Columbia University, New York.</p> <p>She began her reporting career in 1982, when she joined the staff of <i>Philippine Panorama</i>, a widely read magazine. As Ferdinand Marcos gradually lost political power, Sheila reported on human rights abuses, the growing democratic movement, and the election of Corazon Aquino as president. She later joined the staff of the <i>Manila Times</i> as a political reporter, and also wrote special reports for <i>The Manila Chronicle</i>. As a stringer for <i>The New York Times</i> and <i>The Guardian</i> (London), she covered seven attempted coups d'etat against the Aquino government.</p> <p>In 1989, Sheila and her colleagues founded the Philippine Center for Investigative Journalism (PCIJ) to promote investigative reporting. The PCIJ trains journalists in investigative skills, and has provided an environment for in-depth, groundbreaking reporting. The Center has investigated and reported on major social issues including the military, poverty, and corruption. Under Sheila's leadership, the Center became the premier investigative reporting institution in the Philippines and Asia.</p> <p>Sheila is the author and editor of more than a dozen books, including <i>Coups, Cults & Cannibals</i>, a collection of reportage; <i>The Rulemakers: How the wealthy and well-born dominate Congress</i>; and <i>Pork and other Perks: Corruption and Governance in the Philippines</i>. Inglehart



RONALD INGLEHART is a professor of political science and program director at the Institute for Social Research at the University of Michigan.

His research deals with changing belief systems and their impact on social and political change. He helped found the Euro-Barometer surveys and directs the World Values Surveys.

His main current research project is the World Values Survey, a worldwide investigation of socio-cultural and political change. It has carried out representative national surveys of the basic values and beliefs of the people of more than 90 societies on all six inhabited continents, containing almost 90 percent of the world's population. Its first wave of surveys was carried out in 1981. A second wave was completed in 1990-1991, a third wave in 1995-1996, a fourth wave in 1999-2001, and the fifth wave (2005-2007) is currently being processed. This investigation has produced evidence of gradual but pervasive changes in what people want out of life. Because these changes are linked with economic development, their basic direction is, to some extent, predictable. The data from this study have been used in thousands of publications in many languages.

Inglehart's publications include *Modernization and Postmodernization: Cultural, Economic and Political Change in 43 Societies* (Princeton: Princeton University Press, 1997), *Human Values and Beliefs: A Cross-Cultural Sourcebook* (Ann Arbor: University of Michigan Press, 1998), *Rising Tide* (New York, Cambridge University Press, 2003, coauthored with Pippa Norris), *Sacred and Secular* (New York, Cambridge University Press, 2004, coauthored with Pippa Norris) and *Modernization, Cultural Change and Democracy* (New York and Cambridge: Cambridge University Press, 2005, with Christian Welzel). Author of more than 200 publications, he has been a visiting professor or visiting scholar in France, Germany, The Netherlands, Switzerland, Japan, South Korea, Taiwan, Brazil and Nigeria, and he has served as a consultant to the U.S. State Department and the European Union.

He has a Ph.D. from the University of Chicago and teaches courses on comparative politics, democratization and social change in the department of political science at the University of Michigan.

SUSAN MOELLER is the Director of the International Center for Media and the Public Agenda (ICMPA), at the University of Maryland, College Park.

Moeller is also an Associate Professor of media and international affairs at the Philip Merrill College of Journalism and an affiliated faculty member of the School of Public Policy at Maryland. She is the co-director and lead faculty member of the Salzburg Academy Program on Media & Global Change in Austria, an initiative of ICMPA and of the Salzburg Global Seminar.

Moeller has a book *Packaging Terrorism: Co-opting the News for Politics and Profit* (Wiley-Blackwell) forthcoming in October 2008 and another, *Enduring Trauma: How Media Cover Violence and How That Makes Us Feel*, co-authored with Dr. Frank Ochberg, out to readers in press. She is the lead author and editor of a Freedom of Expression Toolkit and Model Curriculum for UNESCO's Division for Freedom of Expression, Democracy and Peace (CI/FED).

Author of *Compassion Fatigue: How the Media Sell Disease, Famine, War and Death* (Routledge) and *Shooting War: Photography and the American Experience of Combat* (Basic Books), Moeller was formerly the director for 8 years of the Journalism Program at Brandeis University. She has been a fellow in the International Security Program and at the Joan Shorenstein Center for the Press, Politics and Public Policy both at the Kennedy School of Government at Harvard University, and twice a Fulbright Professor in international relations, in Pakistan and in Thailand. She taught in the history department at Princeton University, and at Pacific Lutheran University. Moeller received her PhD from Harvard in the History of American Studies, her AM in History, from Harvard, and her BA as a Scholar of The House from Yale. Prior to her graduate work, Moeller was a journalist in Washington, D C.

ICMPA, under Moeller's direction, conducts studies of global media coverage of international news. As an individual researcher, Moeller has authored numerous major media studies, including an NSF-funded study "Media Coverage of Weapons of Mass Destruction" and has written on topics related to media, terrorism and conflict for journals such as *The Harvard International Journal of Press-Politics*, the *Journal of International Affairs*, *Neiman Reports*, *YaleGlobal*, the *American Journalism Review*, as well as for the online editor's blog "Passport" of *Foreign Policy* magazine. Her commentary appears frequently in newspapers and magazines around the world.

PIPPA NORRIS is the McGuire Lecturer in Comparative Politics, John F. Kennedy School of Government at Harvard University.

Her research compares elections and public opinion, political communications, and gender politics. He is publisher/co-editor of <i>Arab Media & Society</i>. HOLLI A. SEMETKO is vice provost for International Affairs and director of Office of International Affairs and The Claus M. Halle Institute for Global Learning, where she is also a professor of political science.

Before coming to Emory in 2003, Dr. Semetko spent 8 years at the University of Amsterdam, the Netherlands, as professor and chair of Audience and Public Opinion Research in the Faculty of Social and Behavioral Sciences. She served as chair of the Department of Communication Science and founding chair of the Board of the Amsterdam School for Communications Research, a school for advanced research recognized by the Royal Dutch Academy of Sciences (KNAW).




Major grants from the European Union and Dutch National Science Foundation supported her work on political communication and media effects in the context of European governance, referendums and elections, and the European political and economic integration process. With more than 80 publications, including five books and 35-plus peer-reviewed journal articles, Semetko has or currently holds elected offices in the American Political Science Association (APSA), International Political Science Association (IPSA), International Communication Association (ICA) and the World Association for Public Opinion Research (WAPOR).

Recognized internationally for her research on news contents, uses and effects in a comparative context, she has received numerous grants, honors and awards including the Samuel H. Beer Prize for the best dissertation on British politics and the ICA's article of the year for "The Divided Electorate: Effects of Media Use on Political Involvement" in *The Journal of Politics*, a leading journal in the field. A fellowship from the German Marshall Fund of the U.S. supported her research in Germany in 1990-91, where she held a visiting position at the Zentrum für Umfragen, Methoden und Analysen (ZUMA) in Mannheim. She was a research fellow at The Shorenstein Center on the Press, Politics and Public Policy at Harvard University in 1994.

She took M.S. and Ph.D. degrees in London at The London School of Economics and Political Science and has held teaching and research positions at Syracuse University, the University of Michigan, and Harvard University's John F. Kennedy School of Government.

In addition to publishing on news and effects in the EU's cross-national comparative context, she is currently working on the topic of media and public diplomacy in an international context. Over the past two decades, she has worked in newsrooms and studied the news and public opinion in national elections in Germany, Spain, and the UK. Her most recent book, co-authored with Claes de Vreese, is *Political Campaigning in Referendums: Framing the Referendum Issue* (Routledge, 2004). The author or co-author of numerous book chapters, her many articles have appeared in such journals as the *British Journal of Political Science*, *Political Communication*, *Journal of Communication*, *Communication Research*, *International Journal of Public Opinion Research*, *European Journal of Political Research* and the *Harvard International Review of Press/Politics*.
